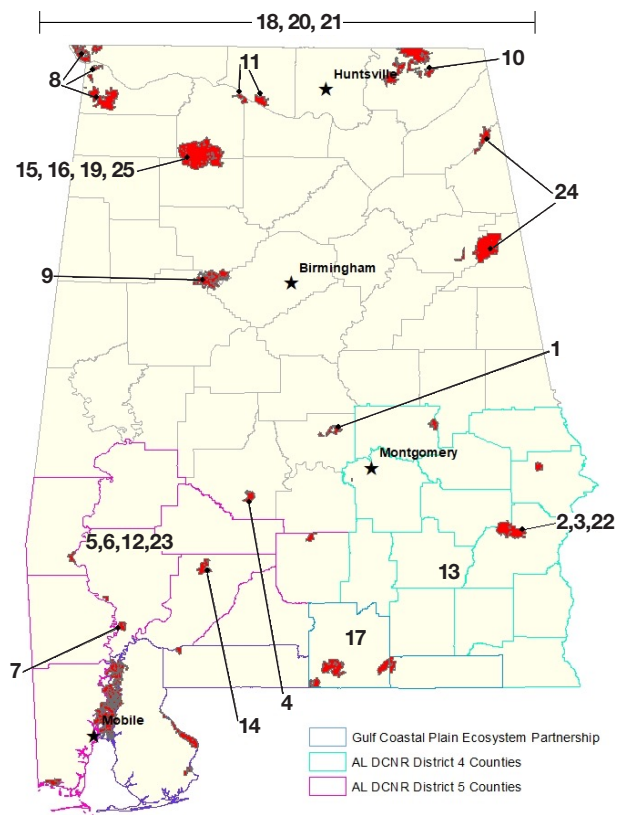




# AL-NWTF 2023-24 Wild Turkey Habitat Projects

Each year, the Alabama State Chapter of the NWTF (AL-NWTF) allocates funds for a variety of wild turkey management projects on public lands throughout the state. Funding for these projects is provided through the NWTF Super Fund from revenue generated by NWTF members at Hunting Heritage banquets, other fundraising events and from proceeds from the sale of AL-NWTF specialty vehicle license plates. Funding for these projects totaled \$183,613 for the 2023-24 project period, which runs from September 1 - August 31, and included 25 projects across the state. When considering the additional \$853,691 of cooperator and in-kind funding provided for these projects, the total program value for the 2023-24 project period is \$1,037,304. More importantly, the projects listed in the table below will enhance over 121,000 acres while providing nesting, brood rearing and foraging habitats critical to help increase the odds of nest initiation, nest success and brood survival. In addition, many of the projects will impact nearly the same acreages on an annual basis due to equipment being used in multiple years.



## Habitat for the Hatch

Alabama has 19 projects contributing to NWTF's newest Habitat for the Hatch Initiative. This landscape-scale effort will lead to more robust wild turkey populations and healthier ecosystems across the Southeast. Through the 2023-24 approved projects, Alabama has over 121,000 acres that will be attributed to the initiative with an overall project value of \$890,531.
